The enclosed Certificate of Approval amends and renews the authorization of National Society for Hebrew Day Schools to operate a Section 1030.3 drug-free prevention service for three years.

The amendment is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) based on the review and approval of Certification Application # 2007-074-3, to add an additional location site at Tomer Devora School for Girls, 4500 Ninth Avenue, Brooklyn.

This renewed Certificate of Approval is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) based on recertification protocols established in accordance with OASAS regulations. The renewal process includes an on-site regulatory compliance review of case records, service management, and facility requirements and general safety; as well as a provider fiscal viability review, if applicable. The resulting compliance ratings serve as the bases for the Certificate of Approval renewal term, up to a maximum of three years, as indicated on the enclosed Compliance Summary Sheet. In addition, National Society for Hebrew Day Schools is responsible for complying with applicable building occupancy limitations and securing any necessary approvals from other governmental entities.

Each provider operating an OASAS-certified service must display a current Certificate of Approval on-site in a location visible to the public. *Please examine the Certificate of Approval carefully and contact the Bureau of Certification by March 14, 2008, if the Certificate of Approval does not accurately reflect your services and/or locations.*






