The above-referenced Certificate of Approval (copy enclosed), due to expire March 31, 2006, will be renewed based on recertification protocols established in accordance with the Office of Alcoholism and Substance Abuse Services (OASAS) regulations.

In conjunction with the renewal process, OASAS requires up-to-date information on use of counseling rooms by drug-free prevention providers who operate certified Section 1030.3 prevention counseling services in public school and/or private school settings. For each certified school building listed on the Certificate of Approval Addendum (copy enclosed), please submit the following by February 14, 2006:

- documentation (face sheet and certification sheet only) demonstrating that, within the last 12 months, each public school building, as applicable, has passed a Fire and Sanitation Inspection by the State Education Department **OR** a copy of the Certificate of Occupancy (or its equivalent, such as a "letter of no objection" stating your intended use from your Municipal Building Department);
- a floor plan for the appropriate section of the building, **identifying (floor and room number) and highlighting the room(s) used for prevention counseling;** and
- notification if a certified site is no longer providing screening and/or prevention counseling services.

Please contact your OASAS Field Office and county representatives should Department of Education, Archdiocese of New York wish to add/replace currently certified school sites. A prior Certification Application submission (PPD-5) to OASAS' Bureau of Certification is required.

Failure to provide the required documentation by the due date will prevent renewal of the Operating Certificate. If you have any questions, please contact me at (518) 485-2272.


