The enclosed Operating Certificate amends and renews the authorization of Twin County Recovery Services, Inc. to operate a Section 1030.3 drug-free prevention service for two years.

This amendment is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) based on the review and final approval of Certification Application #2008-192, for an additional location at Catskill Middle/High School, 347 West Main Street, Catskill and the provider's request to remove the additional location site located at Greenville Central High School, Route 81, Greenville, effective March 12, 2009.

This renewed Operating Certificate is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) based on recertification protocols established in accordance with OASAS regulations. The renewal process includes an on-site regulatory compliance review of case records, service management, and facility requirements and general safety; as well as a provider fiscal viability review, if applicable. The resulting compliance ratings serve as the bases for the Operating Certificate renewal term, up to a maximum of three years, as indicated on the enclosed Compliance Summary Sheet. In addition, Twin County Recovery Services, Inc. is responsible for complying with applicable building occupancy limitations and securing any necessary approvals from other governmental entities.

Pursuant to 14 NYCRR Section 810.17, the previously issued Operating Certificate (original document) must be returned to OASAS' Bureau of Certification immediately.

Each provider operating an OASAS-certified service must display a current Operating Certificate on-site in a location visible to the public. *Please examine the Operating Certificate carefully and contact the Bureau of Certification by March 27, 2009 if the Operating Certificate does not accurately reflect your services and/or locations.*
