The enclosed Operating Certificate renews the authorization of Insight House Chemical Dependency Services, Inc. to operate a Part 819 chemical dependence intensive residential rehabilitation service for three years.

This renewed Operating Certificate is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) based on recertification protocols established in accordance with OASAS regulations. The renewal process includes an on-site regulatory compliance review of case records, service management, and facility requirements and general safety; as well as a provider fiscal viability review, if applicable.
