Operating Certificate #161210191 [Amended] is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) pursuant to the New York State Mental Hygiene Law. This certificate amends the authorization for East House Corporation to operate a Part 819 chemical dependence supportive living service at the administrative site located at 259 Monroe Avenue, Rochester, with the certified sites listed on the Operating Certificate Addendum, effective February 10, 2016. The amendment is based on updated information, adding the children's beds to the Operating Certificate.

East House Corporation is at the approved 60-bed capacity authorized under Operating Certificate #161210191.
