Operating Certificate #151210242 [Amended] is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) pursuant to the New York State Mental Hygiene Law. This Operating Certificate amends the authorization for Bon Secours Community Hospital to operate a Section 816.6 medically managed withdrawal & stabilization service, with the use of methadone, at 160 East Main Street, Port Jervis, effective May 8, 2013.


