Operating Certificate #181110254 is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) pursuant to the New York State Mental Hygiene Law. This Operating Certificate renews authorization for St. Peter's Hospital of the City of Albany to operate a Section 816.6 medically managed withdrawal & stabilization service, without the use of methadone, at 315 South Manning Boulevard, Albany, effective November 11, 2015.

The term of the Operating Certificate is based on the term of St. Peter's Hospital of the City of Albany's current Joint Commission (TJC) accreditation.




