Operating Certificate #180710273 is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) pursuant to the New York State Mental Hygiene Law. This Operating Certificate renews authorization for Nassau Health Care Corporation d/b/a Nassau University Medical Hospital to operate a Section 816.6 medically managed withdrawal & stabilization service, with the use of methadone, at 2201 Hempstead Turnpike, East Meadow, effective July 15, 2015.

The term of the Operating Certificate is based on the term of Nassau Health Care Corporation d/b/a Nassau University Medical Hospital's current Joint Commission (TJC) accreditation.
