Operating Certificate #170410285 is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) pursuant to the New York State Mental Hygiene Law. This Operating Certificate renews authorization for New York City Health and Hospitals Corporation Woodhull Medical and Mental Health to operate a Section 816.6 medically managed withdrawal & stabilization service, with the use of methadone, at 760 Broadway, Brooklyn, effective May 1, 2014.

The three year term of the Operating Certificate is based on the scores identified on the attached *Operating Certificate Renewal Compliance Summary Sheet*.

OASAS received New York City Health and Hospitals Corporation Woodhull Medical and Mental Health's letter dated April 25, 2014, indicating that no changes have been made to the currently approved Medical Detoxification Protocols. 
