Operating Certificate #190110297 is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) pursuant to the New York State Mental Hygiene Law. This Operating Certificate renews authorization for Good Samaritan Hospital of Suffern, N.Y. to operate a Section 816.6 medically managed withdrawal & stabilization service, with the use of methadone, at 255 Lafayette Avenue, Suffern, effective February 3, 2016.

The term of the Operating Certificate is based on the term of Good Samaritan Hospital of Suffern, N.Y.'s current Joint Commission (TJC) accreditation.

OASAS received Good Samaritan Hospital of Suffern, N.Y.'s letter dated February 9, 2016, indicating that no changes have been made to the currently approved Medical Detoxification Protocols. Good Samaritan Hospital of Suffern, N.Y. is responsible for complying with applicable building occupancy limitations and securing any necessary approvals from other governmental entities.


