Operating Certificate #170610510 is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) pursuant to the New York State Mental Hygiene Law. This Operating Certificate renews authorization for The Brooklyn Hospital Center to operate a Section 816.6 medically managed withdrawal & stabilization service, with the use of methadone, at 121 DeKalb Avenue, Brooklyn, effective July 1, 2014.

The three year term of the Operating Certificate is based on the scores identified on the attached *Operating Certificate Renewal Compliance Summary Sheet*.

OASAS received The Brooklyn Hospital Center's letter dated June 9, 2014, indicating that no changes have been made to the currently approved Medical Detoxification Protocols. Please refer to Local Services Bulletin No. 2010-01, OASAS Policy Regarding Medical Detoxification and the Use of Medications (2/11/10), prior to making modifications in these protocols.

The Brooklyn Hospital Center is responsible for complying with applicable building occupancy limitations and securing any necessary approvals from other governmental entities.
