Operating Certificate #171010517 is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) pursuant to the New York State Mental Hygiene Law. This Operating Certificate renews authorization for The Unity Hospital of Rochester to operate a Section 816.8 medically supervised outpatient withdrawal & stabilization service, without the use of methadone, at 1565 Long Pond Road, Rochester, effective November 1, 2014.

The three year term of the Operating Certificate is based on the scores identified on the attached *Operating Certificate Renewal Compliance Summary Sheet*.

OASAS received The Unity Hospital of Rochester's letter dated August 21, 2014, indicating that no changes have been made to the currently approved Medical Detoxification Protocols. Please refer to Local Services Bulletin No. 2010-01, OASAS Policy Regarding Medical Detoxification and the Use of Medications (2/11/10), prior to making modifications in these protocols.
