Operating Certificate #150910521 [Amended] is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) pursuant to the New York State Mental Hygiene Law. This Operating Certificate amends the authorization for The St. Luke's-Roosevelt Hospital Center to operate a Section 816.6 medically managed withdrawal & stabilization service, with the use of methadone, at 1000 Tenth Avenue, New York, effective February 19, 2014.

The amendment is based on OASAS' receipt of a copy of The St. Luke's-Roosevelt Hospital Center's most recent Joint Commission (TJC) survey. The expiration date of this Operating Certificate has been amended to coincide with the expiration date of your current TJC certification.
