Operating Certificate #170511438 is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) pursuant to the New York State Mental Hygiene Law. This Operating Certificate renews authorization for Medical Arts Sanitarium, Inc. d/b/a Cornerstone of Rhinebeck to operate a Section 816.7 medically supervised inpatient withdrawal & stabilization service, with the use of methadone, at 500 Milan Hollow Road, Rhinebeck, effective June 1, 2014.
