Operating Certificate #171211707 is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) pursuant to the New York State Mental Hygiene Law. This Operating Certificate renews authorization for Syracuse Brick House, Inc. to operate a Section 816.7 medically supervised inpatient withdrawal & stabilization service, without the use of methadone, at 1350 University Avenue, Rochester, effective January 1, 2015.


