Temporary Emergency Operating Certificate #E160111920 is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) pursuant to the New York State Mental Hygiene Law. This Operating Certificate authorizes Samaritan Village, Inc. to operate a Part 819 chemical dependence supportive living service at 315 Alexander Avenue, Bronx, effective September 22, 2015.

This 120 day *Temporary Emergency* Operating Certificate is issued to allow for continuation of services while Samaritan Village, Inc. applies for permanent certification.

The certified capacity was determined by the estimated 200sf/pp (per OASAS regulations) or the New York City recommended capacity, whichever was lower. A bi-weekly census report showing progress towards reaching the certified capacity must be submitted to the Bureau of Certification and Systems Management, 1450 Western Avenue, Albany, NY 12203.

Samaritan Village, Inc. is responsible for complying with applicable building occupancy limitations and securing any necessary approvals from other governmental entities.

This *Temporary Emergency* Operating Certificate is to be prominently displayed at the service site.


