Temporary Emergency Operating Certificate #E160111934 is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) pursuant to the New York State Mental Hygiene Law. This Operating Certificate authorizes Acacia Network, Inc. as Sponsor, The Puerto Rican Organization to Motivate, Enlighten, and Serve Addicts, Inc. as Operator to operate a Part 819 chemical dependence supportive living service at 367-369 Howard Avenue, Brooklyn, effective September 22, 2015.

This 120 day *Temporary Emergency Operating Certificate* is issued to allow for continuation of services while Acacia Network, Inc. as Sponsor, The Puerto Rican Organization to Motivate, Enlighten, and Serve Addicts, Inc. as Operator applies for permanent certification.

The certified capacity was determined by the estimated 200sf/pp (per OASAS regulations) or the New York City recommended capacity, whichever was lower. A bi-weekly census report showing progress towards reaching the certified capacity must be submitted to the Bureau of Certification and Systems Management, 1450 Western Avenue, Albany, NY 12203.


