Conditional Operating Certificate #C170412014 is issued by the Office of Alcoholism and Substance Abuse Services (OASAS) pursuant to the New York State Mental Hygiene Law. This *Conditional* Operating Certificate renews authorization for Onondaga-Cortland-Madison BOCES to operate a Prevention Counseling service at 110 Elwood Davis Road, Liverpool, effective May 1, 2016.

In addition, we have changed Drug-Free Prevention Certificates of Approval to Prevention Counseling Operating Certificates. Therefore, Certificate of Approval #120300562 is no longer valid.

The one year term of the *Conditional* Operating Certificate is based on the scores identified on the attached *Operating Certificate Renewal Compliance Summary Sheet*.

A standard Operating Certificate may be issued upon determination by OASAS that Onondaga-Cortland-Madison BOCES's deficiencies noted on the attached compliance summary sheet have been resolved. Such determination will be based on the next scheduled review.


