The enclosed Operating Certificate authorizes Outreach Development Corporation to operate a Part 817 chemical dependence residential rehabilitation services for youth located at 16-12/14 Weirfield Street, Ridgewood. Since Outreach Development Corporation is no longer operating the certified Part 819 chemical dependence intensive residential rehabilitation service at the above location, Operating Certificate #170210092 is no longer valid. Pursuant to 14 NYCRR Section 810.17, the Operating Certificate (original document) must be returned to OASAS immediately.

Outreach Development Corporation is responsible for complying with applicable building occupancy limitations and securing any necessary approvals from other governmental entities.


