RE: Transition of Peer Services back to Standard Rate Codes

Dear Provider;

OASAS in conjunction with OMH and DOH have developed a new weight (.1134) for Peer Advocate Services that will allow those services to be reimbursed through the standard provider rate codes (see Table 2). The transition back to the Standard Rate Codes should simplify the billing process by eliminating the extra claim needed for the separate Enhanced Peer Services Rate Code. The reimbursement amount using the Standard Rate Code will be the same as it was utilizing the Enhanced Peer Services Rate Code with a maximum of 12 units (3 hours) per day.

Effective January 1, 2021, the current Enhanced Rate Codes (Table 1) will produce a zero payout. Claims will be processed but will show a reimbursement amount of zero or may be denied. For appropriate, timely reimbursement, Providers should utilize the Standard Rate Code, for Peer Services delivered from January 1, 2021 forward.

Please note failure to utilize the **Standard Rate Code** as of January 1st could result in:

- Increased work in adjusting claims to the correct rate code
- Delays in reimbursement
- Take backs from plans who are delayed in updating their systems (as per the Medicaid Managed Care Contract plans have up to 60 days to make changes to their systems
