

## STAFFING

Charles K. Post ATC clinical staff are licensed or certified by New York State. We are staffed by a multi-disciplinary treatment team of professionals including:

- Counselors (CASAC)
- Social Workers (LCSW)
- Registered Nurses
- Psychiatric Nurse Practitioner
- Physicians
- Psychiatrist

## LENGTH OF STAY

Length of stay is individualized based on a patient's needs and is typically from 3 to 6 months.

## PAYING FOR THE COMMUNITY RESIDENCE

There is no charge to stay in the Community Residence but outpatient treatment agencies will expect payment for their services either through health care plans they accept, co-pays, Medicaid or self-pay.

## DIRECTIONS TO C.K. POST ATC

From the Northern State Parkway: Take Exit 44 South. From the Long Island Expressway, Exit 53; from the service road, exit south to Bay Shore onto Sagtikos Parkway. Stay in the right lane Exit S2. At the STOP sign, turn left onto H Road. Just before B Road, turn left into the parking lot.

From the Southern State Parkway: Take Exit 41A onto Sagtikos Parkway going north. Exit S2 and bear right at the fork. Turn right at the first cross street. At the next cross street (H Road), turn left. Just before B Road, turn left into the parking lot.

## **INTRODUCTION**

Charles K. Post Addiction Treatment Center (ATC) offers a 42-bed Community Residence for men and women over 18 years old who are struggling with chemical dependency. We are managed by the New York State Office of Addiction Services and Supports. Charles K. Post ATC is accredited by the Commission for the Accreditation of Rehabilitation Facilities (CARF). We are completely tobacco-free.

## **COMMUNITY RESIDENCE**

The mission of C.K. Post ATC is to provide high-quality community residential services for adult men and women who are in need of transitional housing and are addicted to alcohol and other drugs. The program focuses on working with the person in recovery to transition to gainful employment and independent community living.

The Community Residence offers transitional housing that supports recovery from addiction in a stable, substance free environment. We provide case management services to assist you with coordinating outpatient substance abuse, mental health and medical treatment; obtaining gainful employment; implementing a plan for financial stability and establishing healthy relationships with others in recovery.

## **SERVICES OF THE COMMUNITY RESIDENCE**

A case manager is assigned to each client who assists with program orientation; coordinating outside appointments; managing time, money and schedules; implementing recovery and relapse prevention plans and providing vocational/employment support and direction.

Our Community Residence offers clients the following:

- Case Management Services
- Vocational Services
- Educational and Counseling Groups
- Medical and Psychiatric Evaluation
- Medication Assisted Treatment
- 24-Hour Staffing
- On-site Self-Help Meetings (AA, NA, GA)
- Discharge Planning For Aftercare Treatment
- Coordination of Supportive Living
- Evidence-based Practices
- Separate Areas for Men and Women

## **ADMISSION INTO THE COMMUNITY RESIDENCE**

Prospective clients can be referred from any provider including inpatient substance abuse rehabilitation, outpatient programs, psychiatric facilities, probation officers and courts or self-referred.

All candidates are first evaluated to determine need and level of care. Determination is made by C.K. Post interdisciplinary treatment team. Decisions are based on clinical need and bed availability. Justification is provided to candidates who are not accepted into the Community Residence and recommendations and referrals are provided. No person is denied acceptance based on race, ethnicity, religion, nationality or political association.

## **TO BE CONSIDERED FOR THE COMMUNITY RESIDENCE**

- The person must have an alcohol or substance abuse problem
- Lives in an environment that does not support recovery or is homeless
- If unemployed, the person is willing and able to obtain employment
- Willing to attend outpatient treatment
- Does not currently have a serious contagious illness that may threaten the health of others in the program
- Is medically and psychiatrically stable

## **PHARMACOLOGY TREATMENT**

Medication-Assisted Treatment is offered at C.K. Post ATC. These include medications for addictions (Methadone, Suboxone and Vivitrol), Nicotine Replacement Therapy (NRT), psychiatric and medical concerns.
